Treasurer:

Report was sent out. We started November with \$2,656.35 in the bank. November's expenses consisted of only the Verizon bill. We had \$903 in 7th Tradition contributions and \$257.00 in Pink Can contributions. Out of Pink Can, we spent \$281.46 for books on hand and literature for the Meadows, so we have \$158.71 available pink can funds. The District's available funds above prudent reserve are \$2,268.35. November's ending balance including the prudent reserve was \$3,468.35. Motion to approve the November financial report passed unanimously.

Update on our motion, here is what Alex said at the Area Quarterly Meeting:

The first time it was submitted it was decided to not be put on the agenda and an alternate motion was brought to new business that was eventually taken on by the archives committee about area business traditions and practices. Bringing that information back to my district from the archives committee, there was a decision to resubmit the original motion which was not placed on the agenda again for this quarterly. After talking to many people and trying to figure out the best way to address this, it seems to be best to get the collective group conscience of all the DCMs. Sometimes it is difficult to determine if a problem is singular to my district or if it a joint experience amongst other districts. Because denied motions are not distributed amongst the DCMs, in an effort to generate conversation, improve transparency and to have a better report to take back to my district, my action item was to ask if any other districts have experienced motions not being placed on the agenda and if so why. I don't know what I don't know and I appreciate having feedback from the area to be a better informed DCM for my district. Thank you."

Nick from Philipsburg shared that his home group has an elderly member who is mentally disabled and has been really distracting in meetings. Most recently he has threatened people in the meeting. Nick shared that his group has started using the yellow safety card which they read at the start of the meeting and it helps them to set guidelines for conduct during the meeting and ask the gentleman to

leave if he is being disruptive. Nick reminded us that we can escort someone out of a meeting, this does not go against traditions, but we cannot ban them from the meeting.
