We started May with \$2,519.55 in the bank. May expenses totaled \$70.20 and consisted of the Verizon bill. Pink Can had \$45.48 in expenses for Living Sober books for Clinton County. We had \$495.00 in 7th Tradition contributions and \$231.00 in Pink Can contributions. The District's available funds at month end

(above prudent reserve) are \$1,443.37, and the Pink Can available funds are \$486.50. April ending balance, including the prudent reserve, was \$3,129.87. Motion to approve the May financial report passed unanimously.
