Treasurer:

We started July with \$2,937.92 in the bank. District monthly expenses totaled \$457.78 and consisted of \$76.28 for the Verizon bill, \$225.00 for the 3rd Quarter Centre Helps fee, \$50.00 Quarterly Allotment to the Corrections Committee, and

\$106.5 to PI for books. Pink Can had \$147.00 in expenses for Plain Language Big Books for Clinton County. We had \$1,022.90 in 7th Tradition contributions and \$336.00 in Pink Can contributions. The District's available funds at month end (above prudent reserve) are \$2,224.14, and the Pink Can available funds are \$267.90. July ending balance, including the prudent reserve, was \$3,692.04. Motion to approve the June financial report passed unanimously.
