Motion to approve the September and October minutes passed unanimously.

**Treasurer:**

We started October with \$2,620.27 in the bank. District monthly expenses totaled \$264.64 and consisted of \$78.00 for our PO Box rental, \$76.64 for the Verizon bill, \$60 for District Monthly meeting room rental, and \$50 to Pink Can for the 4th Quarter allotment. Pink Can had no expenses in October. We had \$979.85 in 7th Tradition contributions and \$163.00 in Pink Can contributions. The District's available funds at month end (above prudent reserve) are \$2,119.68, and the Pink Can available funds are \$178.80. October ending bank balance, including the prudent reserve, was \$3,498.48
